Retrospective planning permission

Please justify the reason why biodiversity net gain does not apply:

retrospective planning permission, how I offer the following statement Two dead standing trees that posed a safety risk to passing pedestrians and neighbouring properties were removed as part of the works. These trees had no remaining ecological value and presented a hazard due to decay and instability. No healthy or functioning habitats were affected. The development has retained a fully permeable surface and introduced a new laurel hedge along the frontage, which provides improved foraging and nesting opportunities for local bird species and strengthens green infrastructure in line with the Pagham Village Design Statement. The cleft fencing remains wildlife-friendly, allowing movement of small mammals across the site. As a result, the scheme delivers a modest but genuine net gain in biodiversity through the addition of new planting and habitat connectivity, while addressing essential public safety concerns, thereby meeting the requirements of the Environment Act 2021 and Arun District Council's BNG objectives.
