Description of works: Replacement of muddy grass surface with fully permeable gravel, retention of natural drainage (no membranes or grid systems used), installation of cleft post-and-rail fencing with laurel hedge planting at the frontage and installation of replacement 1.8m wooden boundary fencing to the remaining sides for screening and security. This application affects the setting of listed buildings and is in CIL Zone 4 (Zero Rated) as other development.

Thank you for your internet representation made on 16th January 2026 which has been recorded as an objection with the comments as follows:

I am writing to object against planning applications P/165/25/PL and P/72/25/HH. In my humble opinion, both these planning applications are flawed and dangerous for a number of reasons.

I have worked for over 32 years fully employed by N.G.R. Properties Ltd as Maintenance Manager at Barton Manor and their Property Portfolio. Our maintenance depot is based at the top end of Barton Close, next to Barton Manor.

I use this roadway, which is single lane, on average 10-12 times a day, picking up equipment and tools and carrying out maintenance work at Barton Manor and our other properties. Since the land and pathway opposite the Forge/Smithy was taken away and replaced with a poorly constructed carpark and no pathway, I and all the neighbours in Barton Close have been unable to drive in and out of the close without serious complications. The road gets blocked from the gates and we cannot see cars coming out of this carpark.

Your views as made above will be considered before the application is determined.
