Site Address: Land to the North of Nyetimber Forge Barton Close Pagham PO21 4NH
Description of works: Replacement of muddy grass surface with fully permeable gravel, retention of natural drainage (no membranes or grid systems used), installation of cleft post-and-rail fencing with laurel hedge planting at the frontage and installation of replacement 1.8m wooden boundary fencing to the remaining sides for screening and security. This application affects the setting of listed buildings and is in CIL Zone 4 (Zero Rated) as other development.

Thank you for your internet representation made on 17th January 2026 which has been recorded as an objection with the comments as follows:

OWPC80962

I write to object to planning applications P/165/25/PL and P/72/25/HH on the grounds that they are based on inaccurate material evidence. The existing parking at Nyetimber Forge was sold in July 2025 and transferred prior to the first planning application (P/72/25/HH) dated August 2025. This has led to serious complications on the Land to the North opposite Nyetimber Forge, which is obviously within the curtilage of the Forge.

If this application is granted, it will contradict the previous refused applications (P/114/97 and P115/97/L) both dated 9th January 1998, with the address: The Old Forge, Pagham Road, Nyetimber. Furthermore, it will destroy the fragile watercourse land and the unique visual aspects of the historical entrance to Barton Close, which is in an Area of Special Character.

Your views as made above will be considered before the application is determined.
