Description of works: Replacement of muddy grass surface with fully permeable gravel, retention of natural drainage (no membranes or grid systems used), installation of cleft post-and-rail fencing with laurel hedge planting at the frontage and installation of replacement 1.8m wooden boundary fencing to the remaining sides for screening and security. This application affects the setting of listed buildings and is in CIL Zone 4 (Zero Rated) as other development.

Thank you for your internet representation made on 19th January 2026 which has been recorded as support with the comments as follows:

I remember the extent of the area to be as it is when the previous owner lived there, although it was largely unkept. It is now much improved, neat and tidy and the fencing and shrubbery is a fast improvement. I can also confirm that the area was used for parking on a regular basis as the previous owner had three daughters who visited regularly and parked there. The entrance to Barton Close which incorporates Nyetimber Forge and The Smithy has always been a single carriageway with neighbours being neighbourly to accommodate access for each other. The parking opposite Nyetimber Forge has not affected that in any way.

Your views as made above will be considered before the application is determined.
