Description of works: Replacement of muddy grass surface with fully permeable gravel, retention of natural drainage (no membranes or grid systems used), installation of cleft post-and-rail fencing with laurel hedge planting at the frontage and installation of replacement 1.8m wooden boundary fencing to the remaining sides for screening and security. This application affects the setting of listed buildings and is in CIL Zone 4 (Zero Rated) as other development.

Until the current owners of Nyetimber Forge bought the property, and started cleaning up the area, it was an overgrown eyesore. Now, it has been cleaned up, and made the whole area much tidier. But unfortunately, it seems they've been forced to stop their work. To my memory, there has never been any previous 'pathway', though it looked as though the owners were adding one, until the works were stopped. And the area was used for parking previously (albeit in a smaller space, due to it being overrun with brambles).
