Description of works: Replacement of muddy grass surface with fully permeable gravel, retention of natural drainage (no membranes or grid systems used), installation of cleft post-and-rail fencing with laurel hedge planting at the frontage and installation of replacement 1.8m wooden boundary fencing to the remaining sides for screening and security. This application affects the setting of listed buildings and is in CIL Zone 4 (Zero Rated) as other development.

Having the entrance to the close finally cleared and made safe for both drivers and pedestrians is wonderful. It was so overgrown now we are able to see cars entering the close without coming face to face on what was a blind bend.

As a small single lane there is always times that we have to give way to oncoming traffic but I have not experienced any obstructions at the entrance to the close.

I look forward to the work being completed for our safety.
