Description of works: Erection of 5 No. garages in two new buildings for the purposes of parking and domestic residential storage. This application is in CIL Zone 4 (zero rated).

Thank you for your internet representation made on 12th December 2025 which has been recorded as an objection with the comments as follows:

OWPC80301

I firmly object to this application. The road between the garages in a private unadopted road, jointly owned by the owners of the garages and therefore I do NOT give my permission for this to be used to open up the adjoining land attached to 43 Old Manor Road. I understand this application has been made before and firmly rejected and cannot understand yet another application. The owner of the above property has never been given permission or right of way to use our property.

The road, is pot holed in places and the building work and use of 5 further garages, will further erode the infrastructure. The road is also used by local parents and children on their way, to and fro school and people like myself who use mobility aids. If this is allowed to go ahead, it will present a lot of danger to people who legally use their property.

This application should be firmly turned down for the last time.
