I do not appear to have received this letter by email. I do not know why that would be?

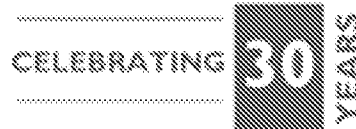
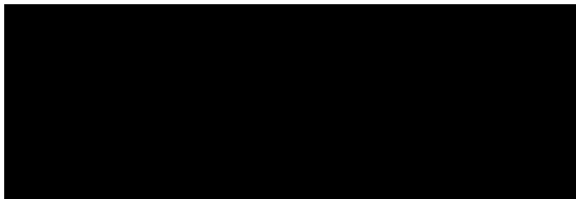
But please now find attached the amended Block Plan.
