Description of works: Erection of 6 No. dwellings with car ports and car parking along with a new ecology and open space area with use of existing access onto The Street. This application is a Departure from the Development Plan, may affect the setting of listed buildings, may affect the character and appearance of the Walberton Green conservation area, is in CIL Zones 2 and 3 and is CIL liable for new dwellings.

Thank you for your internet representation made on 27th January 2025 which has been recorded as an objection with the comments as follows:

This proposed plan should be rejected for the following reasons:

Infrastructure: with hundreds of houses being built in Walberton, and absolutely zero plans or contingencies made for roads, schools, surgeries, and the appalling victorian drainage which consistently overflows into the road where this proposed development will have access from. (I have pictures of people canoeing on The Street at the bottom of Mill Lane)

Environment:

This village cannot afford to lose yet more green space. The area in question is a habitat for hedgehogs which are fast becoming an endangered species. Also having lived here for 30 plus years I can attest to the fact that bats are very local to this area.

Traffic: with the building of the vast estates within the village our roads which are already in a very poor state of repair will only get worse. For proof of this just drive up and down West Walberton lane, and Eastergate lane.

This insane rush, demonstrable greed and hypocrisy to cash in is destroying this village, and should be stopped.

We do not need any more houses in this village. Lets face it only a very few houses of the new developments have been sold anyway. We dont need any more.

Your views as made above will be considered before the application is determined.
