Description of works: Demolition of stable block and erection of 7 No dwelling houses comprising 2 No three-bedroom detached bungalows & 5 No four- bedroom two storey detached houses together with associated car parking and landscaping (resubmission following WA/20/24/PL). This application is a Departure from the Development Plan, falls partly in both Barnham and Walberton parishes and is in CIL Zone 3 and is CIL Liable as new dwellings.

Thank you for your internet representation made on 19th April 2025 which has been recorded as an objection with the comments as follows:

OWPC75857

I strongly object to this development as it has already been rejected by our parish and district council. It falls outside of the New agreed neighbourhood plan. These do not fall into the category of affordable homes and are not the type of housing required in this area. In addition we have issues every year with flooding both of roads and properties. The sewage system cannot cope with the current housing and we have southern water pumping out the drains every winter. Park Lane itself is a single lane unmade road which is unsuitable both for access during the building works and post development with each home presumably expected to have at least 2 vehicles per household. The access does not support this additional traffic. Lake Lane itself has a number of sinkholes which every time they are fixed begin sinking again almost immediately and it should be avoided as access to further developments.

Your views as made above will be considered before the application is determined.
