Description of works: Demolition of stable block and erection of 7 No dwelling houses comprising 2 No three-bedroom detached bungalows & 5 No four- bedroom two storey detached houses together with associated car parking and landscaping (resubmission following WA/20/24/PL). This application is a Departure from the Development Plan, falls partly in both Barnham and Walberton parishes and is in CIL Zone 3 and is CIL Liable as new dwellings.

Thank you for your internet representation made on 28th April 2025 which has been recorded as an objection with the comments as follows:

OWPC76045

I believe that this proposal will have an adverse impact on the wildlife corridor and chalk stream as well as causing damage to the already overloaded existing sewage system both in the surrounding area as well as downstream in the village itself. Lake Lane is susceptible to damage due to the running sands it is built on and this will only make things worse. The access point, Park Road, is totally unsuitable for additional traffic from 7 new properties, let alone heavy machinery and lorries during construction, and especially dangerous for vehicles having to reverse on to Lake Lane to make way for traffic coming the other way. In addition this plan infringes on the New Made Neighbourhood Plan and will significantly affect the convergence of the Parish Boundaries of Walberton, Barnham and Eastergate. I would also stress that should permission be granted Grampian Rules are applied ensuring any infrastructure issues are addressed before the developer commences any work on the site.

Your views as made above will be considered before the application is determined.
