Description of works: Demolition of stable block and erection of 7 No dwelling houses comprising 2 No three-bedroom detached bungalows & 5 No four- bedroom two storey detached houses together with associated car parking and landscaping (resubmission following WA/20/24/PL). This application is a Departure from the Development Plan, falls partly in both Barnham and Walberton parishes and is in CIL Zone 3 and is CIL Liable as new dwellings.

Thank you for your internet representation made on 14th April 2025 which has been recorded as an objection with the comments as follows:

OWPC75611

Lake Lane is already unsafe with speeding traffic cutting through between Barnham and Yapton. The proposed development is just North of a tight single file bend which has seen numerous incidents and near misses.

There is insufficient footpaths for pedestrian access along lake lane and the development of this number of properties would increase traffic, thus increase risk to pedestrians.

There are numerous public footpaths off lake lane making it popular for dog walkers, only 2 weeks ago a dog was badly injured being hit by a car doing significantly over the 30mph speed limit on the bend by the proposed development. If the development were to go ahead it would require traffic calming measures and proper/sufficient footpaths to be made to ensure road safety.

Your views as made above will be considered before the application is determined.
