

Following a review of the application WA/94/25/HH we believe the description does not accurately describe the proposal.

From the plans submitted we believe a more accurate description would be 'Pitched dormer to side of property and loft conversion, consisting of two hip to gables and flat roofed **first-floor extension** to rear of property'.

I have included that that we believe propose a flat roofed first-floor rear extension and not a flat roofed dormer.
