Retrospective planning permission

Please justify the reason why biodiversity net gain does not apply:

The proposed development involves the replacement of an existing barn with a new dwelling on the identical footprint, incorporating hard standing throughout the site. This configuration ensures that the project does not result in any net loss or degradation of onsite habitat, as the entire area is already comprised of sealed surfaces such as concrete or similar impervious materials, which are assigned a biodiversity value of zero under the statutory biodiversity metric. Consequently, the development impacts less than 25 square metres of onsite habitat with a condition score greater than zero and does not affect any priority habitats or linear features exceeding 5 metres, such as hedgerows. This places the application firmly below the de minimis threshold for biodiversity net gain (BNG) requirements, as outlined in the Biodiversity Gain Requirements (Exemptions) Regulations 2024, rendering it exempt from mandatory BNG obligations. 0 1 4 Furthermore, as a small-scale residential project consisting of a single dwelling on a previously developed site with no expansion beyond the existing hard standing, the development avoids triggering BNG by demonstrating negligible ecological impact. The replacement nature of the build maintains the status quo in terms of habitat extent and quality, aligning with exemptions designed to exclude developments that do not contribute to biodiversity loss. This exemption supports proportionate planning processes for low-impact schemes, ensuring compliance with national policy without necessitating biodiversity enhancements or metric calculations, as the threshold criteria for habitat disturbance are not met.
